Professional Experience

Prior to his appointment as Senior Judge, he had retired as a Judge of the Supreme Court of Singapore on 26 February 2014 after having served almost 10 years on the Bench.

During his judicial tenure, he was the Chairman of the Singapore Mediation Centre (2006 to 2011) and of the Legal Heritage Committee (from 2011). He was also Vice-Chairman of the Law Reform Committee (2006 to 2011) and a member of the National University of Singapore's Law Advisory Board.

Prior to his elevation to the Bench in May 2004, he was a Senior Partner and Head of Lee & Lee's Banking & Corporate Department. In his career with Lee & Lee over a 30-year period, he acquired expertise over a broad spectrum of work including banking, corporate finance, mergers and acquisitions, securities regulation, corporate insolvency, income taxation and complex real estate transactions.

Chambers Global, in their directory of The World's Leading Lawyers (in both the 2002 and 2003 editions) named him as one of two leading lawyers in the top tier of Banking and Finance practice in Singapore, while the Asia Pacific Legal 500 (2002 edition) described him as "widely admired".

In 2003, he was also named as one of three experts in Mergers and Acquisitions in Singapore by the International Financial Law Review.

He was conferred the Public Service Medal (PBM) by the President of The Republic of Singapore in 2000 and held the following positions, *inter alia*:
