Effectively bilingual (English / Chinese), Yong Tong has more than 20 years of experience in administering (as Registrar of SIAC) / arguing (as lead counsel) / adjudicating (as arbitrator) international commercial arbitration cases. For 12 years since 2004, Yong Tong was primarily based in Shanghai China and has in depth knowledge and experience of arbitral proceedings conducted in China. During this time, he handled many large arbitration cases involving Chinese parties at CIETAC, HKIAC and SIAC. His practice includes international trade, cross border finance, loan transaction, offshore, company, agency, joint venture, property and construction.

Having returned to Singapore in 2016, Yong Tong is advising a large Chinese offshore corporation with Singapore holding company on operations and business ventures in China, Hong Kong, Australia, Japan, Middle East and Europe. He is advising the corporation as owner of 2 jack-up drilling rigs on termination of project consultancy agreements (USD 6 million) and possible termination of turnkey construction contracts (USD 400 million). Yong Tong continues to act as arbitrator and lead counsel in international arbitration cases.

Apart from contentious work, Yong Tong also handles merger & acquisition, foreign direct investment, cross border finance documentation, loan transaction, restructuring and general corporate advisory work.
