Professional Experience

Mr Cavinder Bull, SC is a Vice-President of the SIAC Court of Arbitration and the Chief Executive Officer of Drew & Napier LLC. He is also a member of the Governing Board of the International Council for Commercial Arbitration (ICCA) and Vice-President of the Asia Pacific Regional Arbitration Group. He was Deputy Chairman of the SIAC from October 2010 to April 2017.

Mr Bull has a vibrant international arbitration practice, representing governments, financial institutions and corporations in complex commercial and investment disputes. He is also actively engaged in trial and appellate advocacy at all levels of Singapore's Courts, handling an expanse of complex litigation matters.

Mr Bull is on the ICSID Panel of Arbitrators and has been appointed arbitrator in ICSID, PCA, ICC, SIAC, LCIA, UNCITRAL and *ad hoc* arbitrations.

Mr Bull is lauded by prominent ranking publications including Chambers and Partners, Legal 500, and the Global Arbitration Review 100. Chambers and Partners Asia-Pacific (2018) ranked him as a Band 1 lawyer in Arbitration for 6 consecutive years; Legal 500 Asia-Pacific (2018) ranked him as a Leading Individual in International Arbitration for 6 consecutive years. Mr Bull has also been identified as a Who's Who Legal – Thought Leader for Arbitration (2018) for 2 years running. He was named "Dispute Resolution Lawyer of the Year 2015" at The Asian Lawyer Emerging Markets Awards 2015. Legal 500 praised him as a "very astute lawyer on strategy and law" while Chambers & Partners describes him as a "consummate advocate"; a "very rare talent in disputes"; and says that "complex arbitrations are his specialisation".

Mr Bull is Co-Chairman of the Singapore Exchange disciplinary committee, a Member of the Securities Industries Council, and a Member of the International Association of Athletics Federations (IAAF) Disciplinary Tribunal in Monaco.

Mr Bull graduated with First Class Honours in law from Oxford University in 1992 and received his LL.M. from Harvard Law School in 1996. He is called to the Bar in Singapore (1994), England (1993) and New York (1996). He is one of a handful of Senior Counsel appointed by the Chief Justice of Singapore before the age of 40.

Arbitration Experience

Mr Bull has presided over ICSID, PCA, ICC, SIAC, LCIA, UNCITRAL and ad hoc arbitrations, sometimes sitting as part of a three member panel and otherwise as sole arbitrator. He has presided over multi-million dollar cases cutting across a wide spectrum of commercial life including cases concerning construction, joint ventures, coal mining, technology and sale of goods. In addition to commercial arbitrations, he is also on the ICSID panel of arbitrators for investment treaty arbitrations and has acted as counsel and arbitrator in numerous investor-state disputes.

Mr Bull is Vice-President of the SIAC Court of Arbitration. He has also been designated by the Permanent Court of Arbitration in the Hague as the Appointing Authority for specific arbitrations.
