Ltd., the developers of The Seaview Condominium, in a landmark High Court decision that clarifies the extent and scope of the liability of the developer, main contractor and architect in a claim for building defects. We successfully defended tortious claims made by the Management Corporation Strata Title Plan No. 3322 for alleged defects in the development amounting to approximately S\$32 million; Asplenium Land Pte. Ltd., a developer in respect of a residential project, in a landmark Court of Appeal decision on the enforceability of a contractual clause limiting an employer's right to restrain a call on a performance bond against a main contractor who was terminated. This landmark decision by the Court of Appeal would mean that it is now possible for employers to exclude or limit the grounds for an injunction to fraud only in the case of unconditional bonds; Kimly Construction Pte. Ltd. in a successful claim against the subcontractor arising from the collapse of a tower crane at the National University of Singapore

In infrastructure/projects, Christopher has been involved in acting for Changi Airport Group (Singapore) Pte. Ltd. in two major infrastructure projects being undertaken at Changi Airport, Singapore – Project Jewel which is a S\$1.47 billion project for the development, construction, lease and management of the iconic aviation-related mixed-use complex at Changi Airport; and in the development of Terminal 4 at Changi Airport on the site of the former Budget Terminal. When completed, Project Jewel and Terminal 4 will boost Changi Airport's handling capacity and augment its position as a leading global air hub.
