In the sports area, in addition to serving since late 2019 as Deputy Chair of FIFA's Dispute Resolution Chamber, and since 2018 as a panellist of the BAT (FIBA Arbitral Tribunal) where I have acted as sole arbitrator in several dozen cases, I sat as sole, wing and presiding arbitrator in dozens of CAS (Court of Arbitration for Sport) cases during my membership on that panel.

I have acted as counsel for numerous parties in commercial and investment arbitrations.

I am adjunct professor at the Carlos 3° University in Madrid, responsible for the training of the school's Vis Moot team.

I am a member of the International Advisory Board of the Research Project on the Social and Psychological Underpinnings of Commercial Arbitration funded by the U.K. Economic and Social Research Council.
