Professional Experience

Constantine has acted as counsel and arbitrator in close to 100 ad hoc and institutional arbitrations, including under the rules of the ICC, LCIA, SIAC, AAA, UNCITRAL and ICSID. In so doing, he has appeared as counsel on some of the largest commercial arbitrations of the last decade, relating to the energy, telecommunications and financial sectors. Constantine has also advised and represented a variety of investors and states in relation to disputes under bilateral and multilateral investment treaties, and was recently counsel of record in high profile ICSID successes for the Republic of Kenya in *World Duty Free v. Republic of Kenya*, and for the Republic of Lithuania in *Parkerings v. Republic of Lithuania*. In recent years, Constantine has also appeared as Sole Arbitrator or Chairman of the Tribunal on a number of occasions.
