He has handled many arbitration cases as lead counsel, presiding arbitrator, co-arbitrator and sole arbitrator. His arbitration appointments include being a Fellow of the Chartered Institute of Arbitrators (UK) and the Singapore Institute of Arbitrators (SIARB). He is also on the panel of arbitrators of the Singapore International Arbitration Centre (SIAC), China International Economic and Trade Arbitration Commission (CIETAC), Hong Kong International Arbitration Centre (HKIAC), Shanghai International Arbitration Centre (SHIAC) and Kuala Lumpur Regional Centre for Arbitration (KLRCA).
