After completing his bachelor's degree in law and humanities, he was admitted to the bar in the year 1972 and started practicing predominantly before the High Court of Madhya Pradesh under the tutelage and mentorship of his father late Shri R.P. Verma, who was a distinguished lawyer of his time.

As a lead counsel, he was often instructed by renowned law firms in complex and challenging disputes before the trial and appellate courts. He practiced as an advocate until his elevation as a Judge of the High Court of Madhya Pradesh in the year 1994. He was appointed as the Administrative Judge of the High Court of Madhya Pradesh in 2005. During this period, he also served as the Welfare Commissioner for the victims of the Bhopal Gas Tragedy. In 2008, he was transferred to the High Court of Karnataka as the senior most judge on the bench and served as the Acting Chief Justice until his appointment as the Chief Justice of Rajasthan High Court. Thereafter, from 2009 to 2012, he served as Judge of the Supreme Court of India.

As an appellate court judge from 1994 to 2012, he was involved in several hundred judgements both as a judge in three different High Courts and the Supreme Court of India in matters concerning administrative law, arbitration law, criminal law, constitutional law, company law, insurance law, family law, company law, service law, taxation etc.
