### **PRACTICE**

He has been involved in disputes involving foreign law including in India, Hong Kong, the Kingdom of Saudi Arabia, Nepal, Singapore, UAE, USA (including New York, Texas, California), Europe (including Spain and Poland), South Africa and Gibraltar.
