# EXAMPLES OF ARBITRATION CASES

Often acts as an arbitrator or party representative in national (VCCA) and international (VCCA, ICC, SCC, etc.) arbitration cases, as well as cases under UNCITRAL arbitration rules. Several illustrative cases include:

- Chairman of the tribunal under UNCITRAL Arbitration Rules in a dispute between an oil refinery and a railway company in excess of EUR 150 million:
- Party-appointed arbitrator in a multiparty ad hoc arbitration under UNCITRAL Arbitration Rules between an oil refinery and UK insurance companies in excess of EUR 200 million;
- Party-appointed arbitrator in the Vilnius Court of Commercial Arbitration (VCCA) case under VCCA Arbitration Rules between an oil refinery and a railway company over the transportation tariffs in excess of EUR 100 million;
- Sole arbitrator appointed by the ICC Court of Arbitration in an ICC arbitration case No. ICC18580/GZ/MHM between eastern European and Portuguese companies relating to international trade contracts;
- Sole arbitrator appointed by the ICC Court of Arbitration in an ICC arbitration case No. ICC20907/MHV between an Estonian and Finish companies relating to the sale of equipment;
- Member of the team in ICSID case UAB "Arvi ir Co" ir UAB "Sanitex. V. Republic of Serbia Nr. ARB/09/21;

- Party representative in various ICC, SCC, and VCCA cases relating to the sale of companies, commercial real estate, international trade, gas supply, etc.;
- Arbitrator (chairman or party-appointed) in about 60 arbitration cases under VCCA arbitration rules including cases involving municipalities, banks, energy, telecommunication, construction, aviation, trading, and other companies, relating to questions of shareholder rights and M&A disputes, insurance, advisory liability, director liability, construction, trade, telecommunication services, transportation, manufacturing and provision of services, etc.
- Party representative in challenging enforcement of foreign arbitral awards;
- Expert witness in the English courts regarding Lithuanian arbitration law.

### EXAMPLES OF TRANSACTIONAL EXPERIENCE

Advised in many significant international transactions taking place in Lithuania over a couple of decades including privatizations, mergers and acquisitions, real estate projects, sale of commercial property, Eurobond, IPOs and GDR issues, international syndicated loans, project finance, private equity, etc. Examples of publicly known projects include:

- Euro 220 million acquisition of the leading mobile telecommunications operator Omnitel by TEO LT;
- Euro 500 million acquisition and financing of acquisition (including bond issue) of the leading mobile telecommunications operator Bite;
- Euro 600 million sovereign Eurobond issue;
- First international IPO in Lithuania (and subsequently several others);
- Sale and acquisition, as well as financing of the acquisition of a number of commercial real estate projects, such as shopping centers, hotels, and logistic centers;
- Acquisition of a chemical company;
- Acquisition of the major Lithuanian alcohol production facility;
- A few different acquisitions and mergers of the Lithuanian banks;
- Acquisition of the shipping (ferry line) company by a Danish investor;
- Representing the Government of Lithuania in the sale (privatization) of the Lithuanian Gas Company Lietuvos Dujos;
- Sale (privatization) of the refinery and crude pipeline to a strategic investor.
