ABOUT ME

A founding partner of TSMP and an influential figure in the legal community, Shen Yi read law at St John's College, Cambridge University, graduating in 1991. He subsequently topped the English Bar Examinations, and was called to the Singapore bar in 1993. Since then, he has practised exclusively in dispute resolution, primarily as counsel, and occasionally as arbitrator. He was appointed Senior Counsel in 2008 at age 40. He was elected a Master Bencher of The Middle Temple in 2016.

Recognised internationally as a leading commercial litigator in the global journals from International Who's Who Legal to Chambers Global, Shen Yi chooses to practise a wide spectrum of corporate, financial, infrastructure, trusts and insolvency law to keep his adrenaline pumping and neurons challenged. Insatiably curious and an avid reader, he believes that to fully understand the brief, a wide-ranging and eclectic knowledge of economics, history, business, finance, engineering, science and psychology is critical. Shen Yi is happiest when diving headfirst into complex disputes, which require in-depth forensic study, expert legal knowledge and precision advocacy. His submissions before the Court of Appeal are just as likely to include a line from Spiderman, the movie (Uncle Ben: "with great power comes great responsibility"), as a quotation from Shakespeare or Wilde.

Although he spends most of his waking hours solving his clients' problems and bearing the legal weight of their burdens, Shen Yi is fully committed to the wider issue of the role of the legal community in Singapore's social and economic system. He served as the President of the Law Society, and as Vice-President of the Senate of the Singapore Academy of Law from 2015-2016. A firm believer that pro bono legal work is a debt that every lawyer owes, he also currently serves on the board of the Law Society Pro Bono Services Limited, a registered charity.

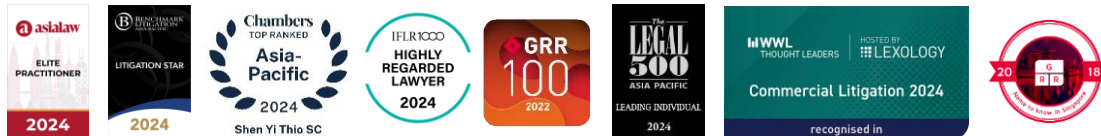
