WELCOME REMARKS



Mr Kevin Nash Registrar, SIAC

As Registrar of the Singapore International Arbitration Centre, Kevin leads the SIAC Secretariat in the provision of case management services. Over the course of the past decade, Kevin has overseen the administration of thousands of international cases under all versions of the SIAC Rules and the UNCITRAL Arbitration Rules. Under the Singapore International Arbitration Act 1994, Kevin is the statutory taxation authority and he is empowered to authenticate and certify awards and arbitration agreements.

Kevin worked closely on the revisions to the SIAC Rules 2013, SIAC Rules 2016, SIAC Investment Arbitration Rules 2017, and leads the SIAC Secretariat on the drafting of the seventh edition of the SIAC Rules. He is an active participant at UNCITRAL Working Group II (Dispute Settlement) and UNCITRAL Working Group III (ISDS) and frequently speaks, lectures and conducts training on contemporary issues in arbitration.

Recognised for being 'truly exceptional in his passion for, and knowledge of, international arbitration', Kevin is listed by Who's Who Legal as a Global Leader and National Leader for Southeast Asia in international arbitration. Described as a 'rock star of arbitration' and 'a calm presence and a safe pair of hands for the most complex matters', peers and clients say that he is 'without equal in the region, in terms of institutional knowledge and expertise in international arbitration' and that 'no one knows more about arbitration in Singapore'.

Kevin is qualified as a Barrister and Solicitor with the Law Society of Upper Canada. He speaks English and French.

OPENING ADDRESS



Hon. Alexander G. Gesmundo Chief Justice, Supreme Court of the Philippines

Chief Justice Alexander G. Gesmundo was appointed as the 27th Chief Justice of the Philippines on April 5, 2021. He first joined the Supreme Court as its 178th Associate Justice on August 14, 2017. Prior to his appointment to the High Court, he served as Associate Justice of the Sandiganbayan for 12 years.

Chief Justice Gesmundo entered government service in August 1985 as Trial Attorney in the Office of the Solicitor General. He was on Seconded Appointment as Commissioner of the Presidential Commission on Good Government from 1998 to 2001. In 2002, he was promoted to Assistant Solicitor General. He continued to serve in the Office of the Solicitor General until his appointment to the Sandiganbayan in 2005.

Prior to joining the government, Chief Justice Gesmundo worked as Research Analyst from 1977 to 1979 with Business Day Corporation, publisher of the business newspaper Business Day and Top 1000 Corporations of the Philippines where his articles were published. In 1979, he worked as Market Research Officer at the Office of the Australian Trade Commissioner, Australian Embassy, Manila, and continued as its Marketing Officer from 1980 to 1985.

Chief Justice Gesmundo is a member of the Corps of Professors of the Philippine Judicial Academy (PHILJA) as Professorial Lecturer in Remedial Law. He also previously served as Vice-Chairperson of the PHILJA's Department of Remedial Law. The Chief Justice has also taught Remedial Law subjects in various universities and was the Examiner in Remedial Law in the 2009 and 2015 Bar examinations.

Chief Justice Gesmundo obtained his Bachelor of Science degree in Economics from the Lyceum of the Philippines University in 1977 and his Bachelor Laws degree from the Ateneo de Manila University in 1984. He joined the Philippine Bar in April 1985.

Mdm Rahayu Mahzam Senior Parliamentary Secretary, Ministry of Health & Ministry of Law, Singapore

Mdm Rahayu Mahzam is Senior Parliamentary Secretary at the Ministry of Health and Ministry of Law. She is also the Deputy Chairperson of the REACH Supervisory Panel, which seeks to engage Singaporeans on national and social issues.

At the Ministry of Law, she oversees policies and initiatives relating to access to justice, international civil and criminal cooperation, and international rule of law.

Prior to joining the Government, Mdm Rahayu was a lawyer, specialising in civil litigation and family law. She also served as Deputy Registrar at the Syariah Court of Singapore from 2013 to 2015.

Mdm Rahayu has been a Member of Parliament since September 2015. In Parliament, she has championed the interests of the special needs' community, youth development, as well as efforts to empower women and preserve a strong, multi-racial and multi-religious community.

Mdm Rahayu graduated from the National University of Singapore with a LL.B. in 2003.

Usec. Irene De Torres Alogoc *Executive Director V, Office for Alternative Dispute Resolution, Philippines*

Undersecretary Irene is the inaugural Executive Director V of the Office for Alternative Dispute Resolution, an attached agency of the Department of Justice of the Philippines. She is currently a member of the Technical Working Group on the Filtering Mechanism of the Supreme Court. She is also the Principal Representative of the Justice Department to the Lupong Tagapamayapa Incentives Awards (LTIA) and serves as Chairperson of the LTIA National Board of Judges.

She has more than fifteen (15) years of extensive law practice and is a professor of Law in various universities in the country. She has held various key positions in all three branches of the Philippine government.

She completed the Negotiation and Leadership Course at the Harvard Law School and the Leadership Training Program at the United Nations (UN). She likewise had her Comprehensive Course on International Commercial Arbitration under the Chartered Institute of Arbitrators - New York Branch and the Columbia Law School, and Strategic Conflict Management for Professionals at the Singapore Mediation Centre. USec. Irene is a trained Arbitrator and trained File Counsel of the Philippine Dispute Resolution Center, Inc. (PDRCI).

USec. Irene represents the Philippines in the United Nations Commission on International Trade Law (UNCITRAL) Working Group II (Arbitration and Conciliation/Dispute Settlement) and Working Group III (Investor-State Dispute Settlement Reform).

USec. Irene is the author of two (2) books titled "Philippine Alternative Dispute Resolution and Gabay ng Barangay sa Mediation, Arbitration at Conciliation," which highlight the different ADR mechanisms and practices in the country. Among her advocacies are to mainstream ADR in the Philippine justice system, empower government agencies with effective ADR mechanisms, organise quality skills training programs for ADR practitioners, and standardise the ADR profession in the Philippines.

CLOSING REMARKS



Ms Adriana Uson Director & Head, Americas, SIAC

Adriana Uson is the Director & Head (Americas) of the Singapore International Arbitration Centre (SIAC) where she leads and oversees SIAC's activities in North and Latin America. In 2020, Adriana established SIAC's first office outside of Asia in New York.

Adriana has more than a decade of experience in dispute resolution and has served as counsel on international arbitrations, arbitrator, and institutional representative.

Adriana first joined SIAC as Counsel, during which time she administered hundreds of cases across a range of seats and governing laws. She was involved in the drafting of the SIAC Rules 2016, SIAC Investment Arbitration Rules 2017, and the SIAC Practice Note on third party funding. She was also a member of the Singapore Institute of Arbitrators working group that published the SIArb Guidelines on Party-Representative Ethics.

Prior to rejoining SIAC, Adriana was a disputes lawyer at a global law firm, where she advised and represented clients in international arbitrations conducted under the auspices of SIAC, ICC, ICSID, and HKIAC. She also previously worked as a litigation and dispute resolution lawyer at a top-tier Philippine law firm.

Adriana has been recognised by Who's Who Legal as a National Leader for Southeast Asia in 2023 and as an Arbitration Future Leader in 2024. She was recognised as "a brilliant and focused practitioner" who is "a pleasure to work with in every respect". One source notes that she "possesses a depth of knowledge in the arbitration space that few others can match". Adriana is also acknowledged as a "diligent and thoughtful international arbitration lawyer".

Adriana represents SIAC at UNCITRAL Working Group II and UNCITRAL Working Group III. She serves as Regional Lead for the Americas in the newly formed Young SIAC Council and is a Fellow of the Singapore Institute of Arbitrators and the Philippine Institute of Arbitrators. She is listed as an arbitrator on the panels of SIAC and the Philippines' Office for Alternative Dispute Resolution.



Ms Thea Elyssa Vega Counsel, SIAC

Prior to joining the SIAC, Thea was an Associate Solicitor at the Office of the Solicitor General in the Philippines where she handled criminal, civil, international commercial, and investor-state arbitration. She has also handled cases across various sectors such as energy, public-private partnerships, gaming, competition law, among others. She was also once part of the Philippine delegation in the UNCITRAL Working Group III on Investor-State Dispute Settlement Reform. She also worked as legal intern at the Philippine Supreme Court.

Thea earned her Juris Doctor Degree (J.D.) from the Ateneo de Manila University School of Law in the Philippines and is admitted to the Philippine Bar.

Timothy John R. Batan has been working in the transportation department for five years, first as a Senior Project Development Officer for DOTr Planning, Project Development, and Private-Public Partnership Unit in 2015 where he worked with on several maritime, airport development, port modernization, and varying mass transit projects until he was eventually appointed as an Assistant Secretary for Railways in June 2017, and again as the Undersecretary for Railways in February 2018.

Ms Jane E. Yu Senior State Solicitor, Office of the Solicitor General, Republic of the Philippines

Jane E. Yu is a Senior State Solicitor at the Office of the Solicitor General of the Republic of the Philippines where she began her practice in international investment dispute resolution in 2002. She is one of her office's principal handling solicitors of complex investment and commercial arbitration proceedings before the ICSID, the ICC and in ad hoc arbitrations before the PCA. She also acted as legal advisor to Philippine government agencies involved in investment treaty negotiations. She is designated as alternate representative to the UNCITRAL Working Group on the Reform of Investor-State Dispute Settlement.

In 2012, she was also a member of the Investor-State Mediation Sub-Committee that drafted the IBA Rules for Investor-State Mediation and one of the state representatives who peer-reviewed the 2011 APEC-UNCTAD Handbook for Negotiators of International Investment Agreements. In 2009, she assisted in presenting the Philippine position on reform of the ICSID Rules on annulment proceedings. She was also the project overseer for APEC of three Investor-State Dispute capacity building projects in the region.

She is currently on the list of foreign arbitrators of the Shenzhen Court of International Arbitration (SCIA). She is also an Assistant Vice-President of the Philippine Institute of Arbitrators. She received her Master of Laws Degree in International Dispute Resolution from the Center for Commercial Law Studies of the Queen Mary University of London.



Mr Manuel F. Santos, Jr. Government Corporate Attorney, Office of the Government Corporate Counsel, Philippines

Manuel F. Santos Jr., or Jun, is a Government Corporate Attorney at the Office of the Government Corporate Counsel, an attached agency of the Philippine Department of Justice. He is the Vice-Chairperson of the OGCC Learning and Development Committee. Concurrently, he serves as the Acting Corporate Secretary of Duty Free Philippines Corporation, one of the OGCC's client government corporations.

Before joining the OGCC in 2003, he worked as a Court Attorney in the Philippine Supreme Court at the Office of Associate (later Chief) Justice Reynato S. Puno from 2000 to 2003. He finished his Bachelor of Arts, cum laude, and Bachelor of Laws degrees from the University of the Philippines – Diliman.
