SIAC sets a New Record in 2019

2019 saw SIAC set a new record with 479 new case filings. Of the 479 cases, 454 (95%) were cases administered by SIAC, which is also an all-time record. The remaining 25 (5%) cases were *ad hoc* appointments. This is the third consecutive year that SIAC's caseload has exceeded 400.

SIAC's total sum in dispute for 2019 was USD 8.09 billion (SGD 10.91 billion) which was a 14.6% increase from 2018.

Parties from 59 jurisdictions chose to arbitrate at SIAC in 2019. While India, China and USA retained their top foreign user rankings, other significant contributors to SIAC's caseload included new entrants from Brunei, the Philippines and Thailand, as well as parties from Switzerland, UAE and UK, which is testament to SIAC's global appeal to users from diverse legal systems and cultures.

The following are some highlights from 2019.

SIAC Year in Review 2019

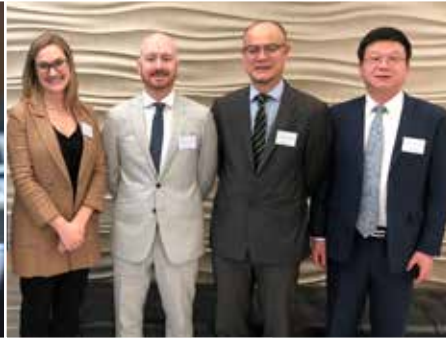

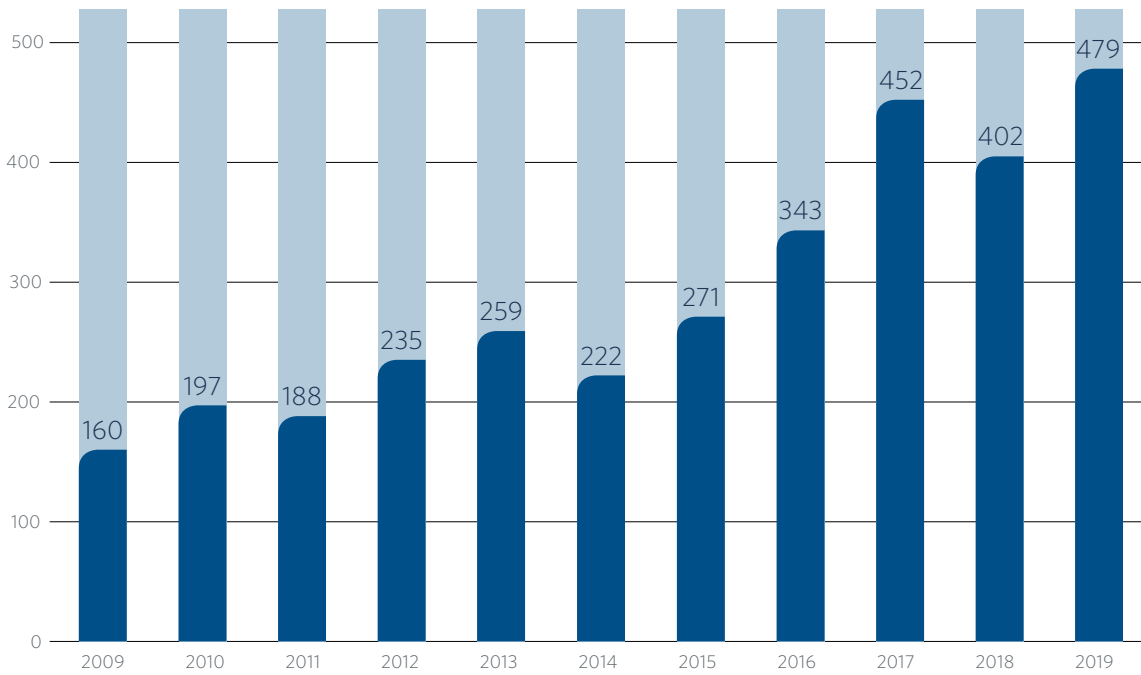

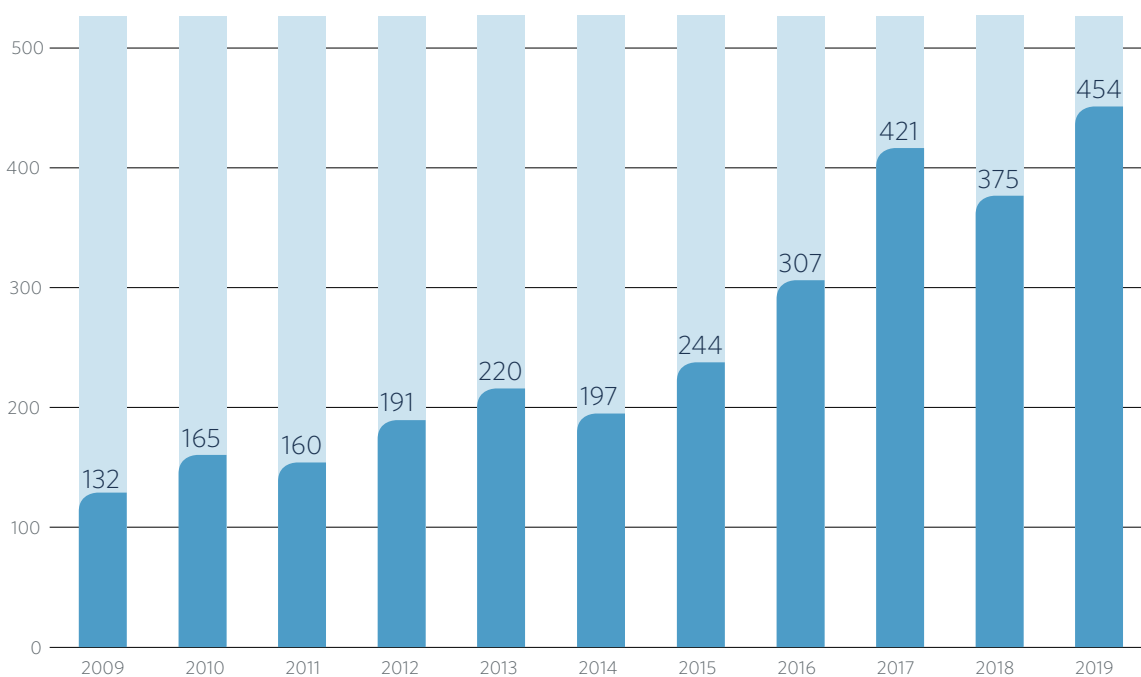
New Cases

In 2019, SIAC received 479 new cases. SIAC administered 454 (95%) of these new cases, with the remaining 25 (5%) being *ad hoc* appointments. SIAC has received over 400 new cases in each of the last 3 years.

Sum in Dispute

The total sum in dispute for all new case filings with SIAC amounted to USD8.09 billion (SGD10.91 billion)*. The total sum in dispute for new SIAC-administered cases amounted to USD6.69 billion (SGD9.02 billion)*.

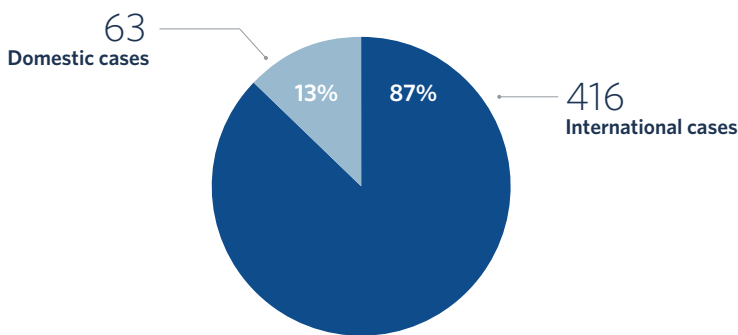
The average value of new cases filed was USD30.99 million (SGD41.81 million)*, and the average value of new SIAC-administered cases was USD27.86 million (SGD37.60 million)*. The highest sum in dispute for a single administered case was USD1.41 billion (SGD1.90 billion)*.

Geographical Origin of Parties

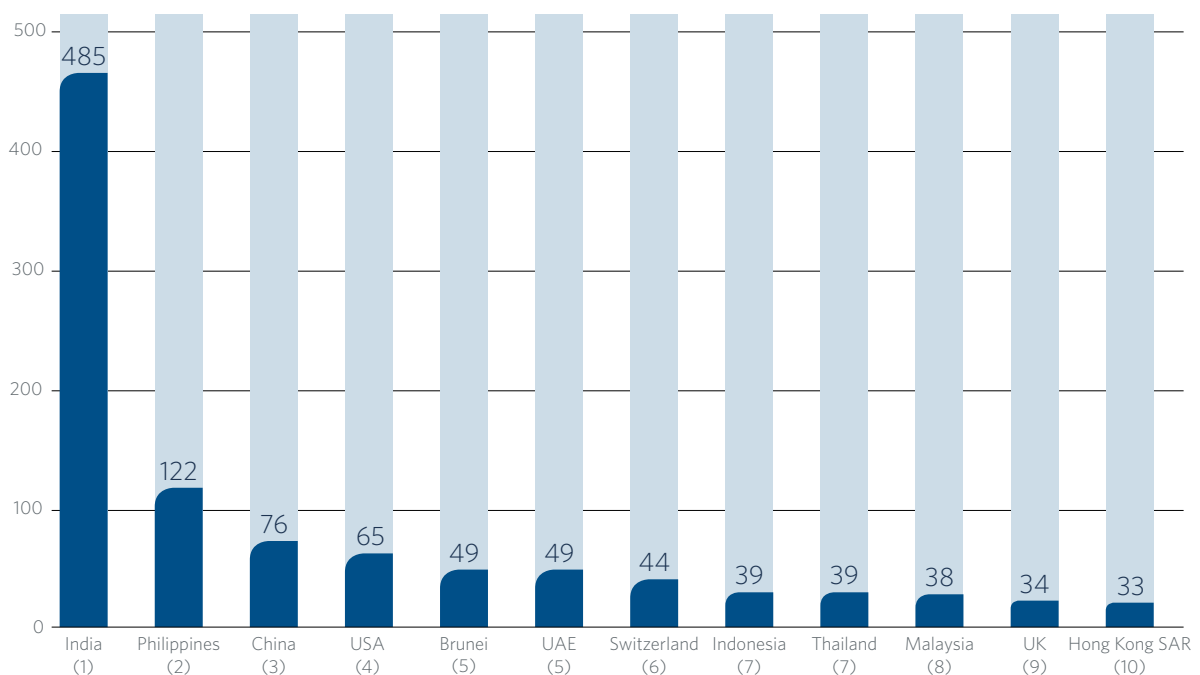
87% (416) of new cases filed with SIAC in 2019 were international in nature.

In 2019, India was the top foreign user of SIAC. While China and the United States of America remained strong contributors to SIAC's caseload, Brunei, the Philippines and Thailand entered the top 10 foreign user rankings for the first time. SIAC's other top foreign users were from a mix of common law and civil law jurisdictions.

SIAC received cases from parties from 59 jurisdictions[^], which are detailed below.

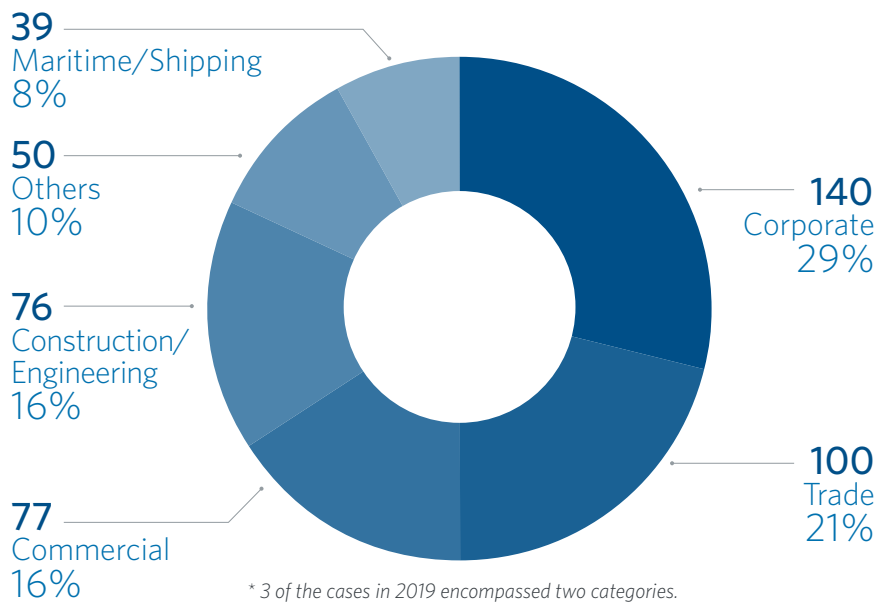

Arbitrator Appointments

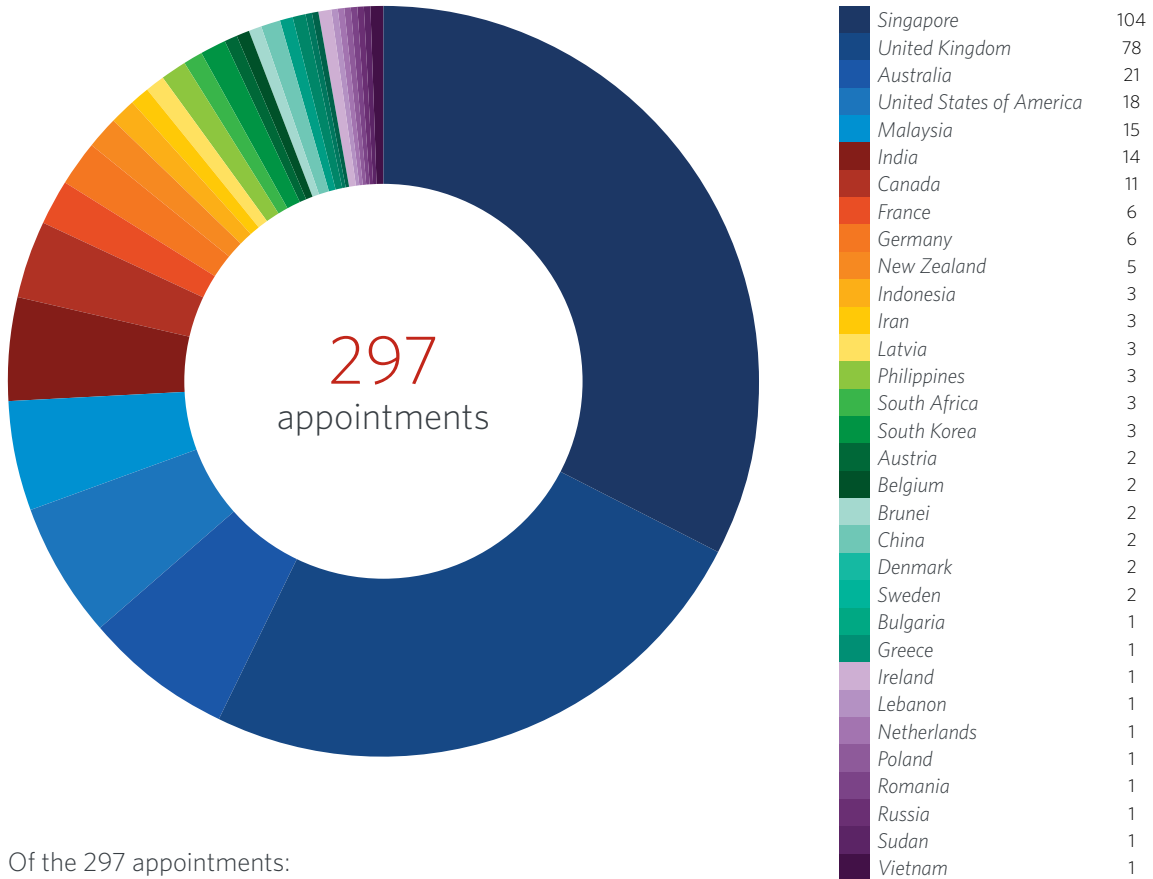
In 2019, SIAC made a total of 159 individual appointments of arbitrators to 145 sole arbitrator tribunals and 14 appointments to three-member tribunals. Of these arbitrator appointments, 138 were appointments made under the SIAC Rules, 2 were appointments made in cases administered under other Rules and the remaining 19 were made in *ad hoc* arbitrations.

Arbitrators appointed by SIAC in 2019 included arbitrators from Australia, Bulgaria, Canada, China, Denmark, France, Germany, Greece, India, Indonesia, Iran, Ireland, Latvia, Lebanon, Malaysia, the Netherlands, New Zealand, the Philippines, Romania, Singapore, South Africa, South Korea, Sweden, the United Kingdom and the United States of America.

A total of 138 arbitrators were nominated in 2019 and confirmed by SIAC. They included arbitrators from Australia, Austria, Belgium, Brunei, Canada, China, Germany, India, Indonesia, Iran, Malaysia, New Zealand, Philippines, Poland, Russia, Singapore, South Africa, South Korea, Sudan, the United Kingdom, the United States of America and Vietnam.

Geographical Diversity in Arbitrator Appointments

The following chart shows the geographical diversity of arbitrators appointed*:



Of the 297 appointments:

- 114 (36%) were non-Singaporean arbitrators appointed by SIAC
- 79 (25%) were non-Singaporean arbitrators nominated by parties
- 21 (6%) were non-Singapore arbitrators nominated by co-arbitrators
- 60 (19%) were Singaporean arbitrators appointed by SIAC
- 31 (10%) were Singaporean arbitrators nominated by parties
- 13 (4%) were Singaporean arbitrators nominated by co-arbitrators

* The total count of 318 arbitrators takes into account 21 arbitrators with dual nationality.

Gender Diversity in Arbitrator Appointments

Of the 159 arbitrators appointed by SIAC, 58 (or 36.5%) were female.

Of the 33 members of SIAC’s Court of Arbitration, 10 (or 30.3%) are women.

Women constitute 60% of SIAC’s Management and Secretariat.

Challenges to Arbitrators

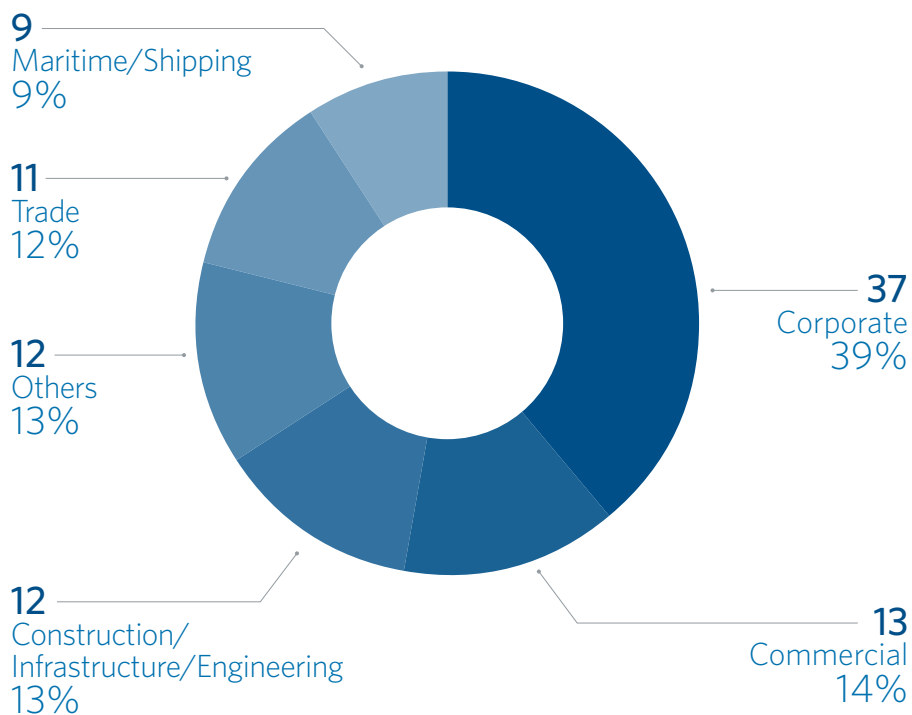
2 challenges to arbitrators were decided by the SIAC Court of Arbitration in 2019. Both were rejected by the SIAC Court of Arbitration.

Emergency Arbitration

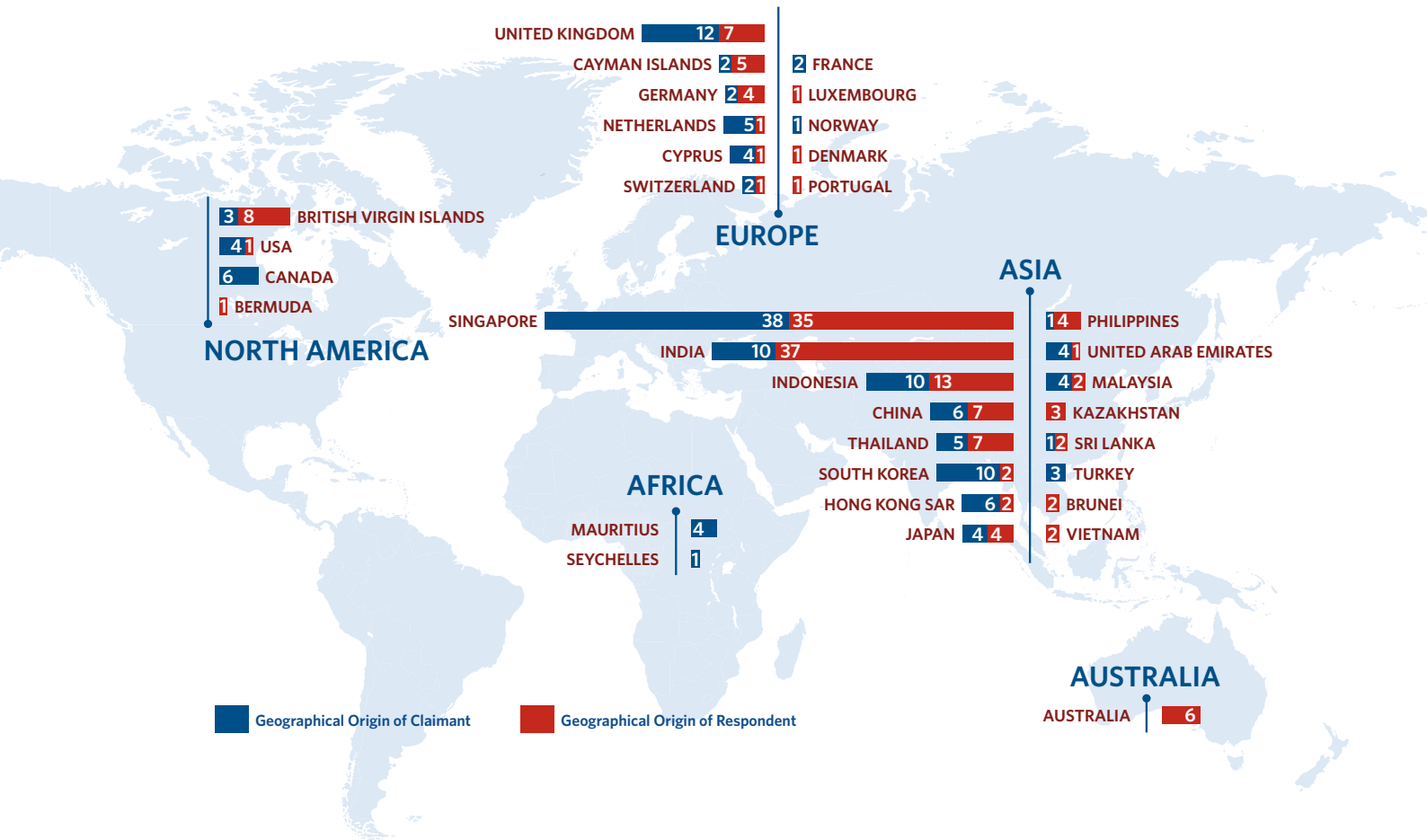
The Emergency Arbitrator (**EA**) provisions were introduced in the SIAC Rules 2010 to address the need for emergency interim relief before a Tribunal is constituted. SIAC was the first international arbitral institution in Asia to introduce EA provisions in its arbitration rules.

In 2019, SIAC received 10 applications to appoint an EA. SIAC accepted all 10 requests, bringing the total number of EA applications accepted by SIAC since the introduction of these provisions in 2010 to 94.

Since 2010, parties have applied for emergency relief in disputes arising out of the following sectors:

Expedited Procedure

The Expedited Procedure (**EP**) was introduced in 2010 and is another popular mechanism for saving time and costs.

In 2019, SIAC received 61 requests for EP, of which 32 requests were accepted. SIAC has received a total of 534 EP applications (and accepted 319 requests) since the introduction of these provisions in 2010.

Early Dismissal of Claims and Defences

SIAC introduced the Early Dismissal (**ED**) procedure in 2016, making SIAC the first among the world’s major commercial arbitration centres to adopt this provision in its Rules.

In 2019, SIAC received 8 ED applications. Of the 8 applications received, 5 applications were allowed to proceed and 3 applications were not allowed to proceed under Rule 29.3 of SIAC Rules 2016. Of the 5 applications that were allowed to proceed, 1 application was granted, 2 were rejected, and 2 are pending.

Consolidation and Joinder

Since the introduction of the provisions on consolidation and joinder in 2016, SIAC has received 179 applications for consolidation, and 29 applications for joinder.

In 2019, SIAC received 53 applications for consolidation. Of the 53 applications for consolidation, all 53 were made prior to the constitution of the Tribunal. As of 31 December 2019, 31 applications had been granted by the SIAC Court of Arbitration.

SIAC received 10 applications for joinder in 2019. Of the 10 applications for joinder, all 10 applications were made after the Tribunal had been constituted. As of 31 December 2019, 4 applications had been granted by the Tribunal.

Governing Laws

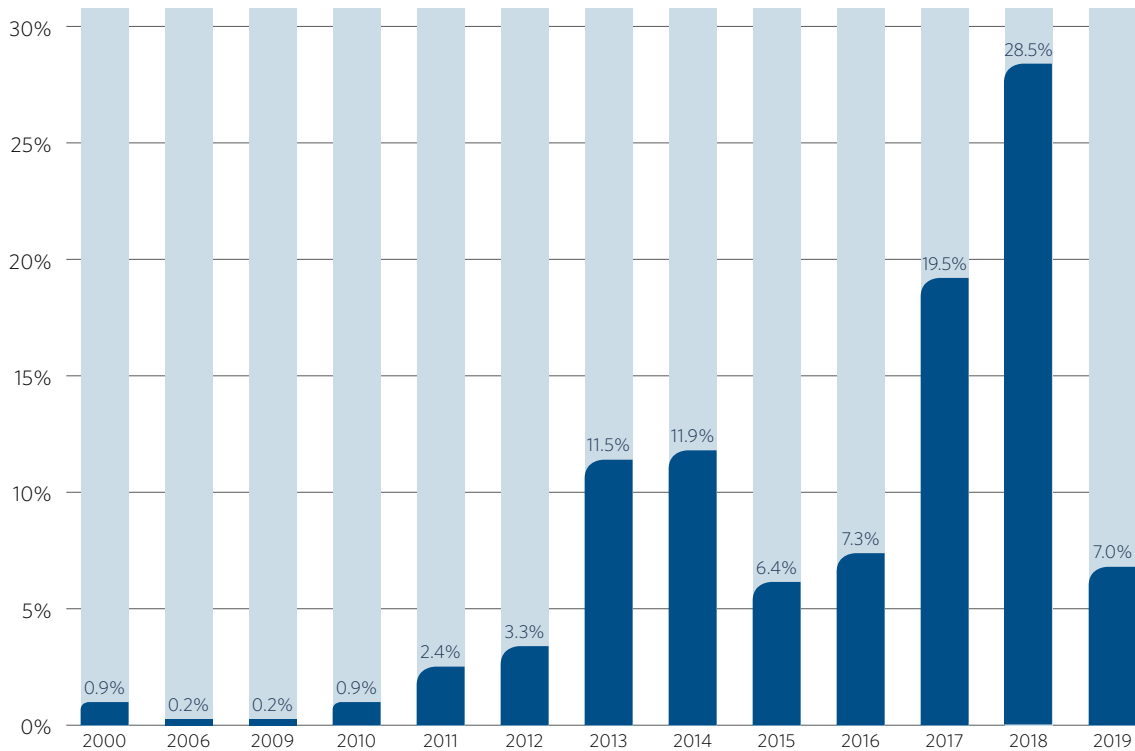

Awards

169 awards were issued in 2019.

All awards are carefully scrutinised by the Secretariat and approved by the Registrar. In addition to matters of form, the Registrar draws the Tribunal's attention to points of substance for the Tribunal's consideration, always bearing in mind that it is the Tribunal which makes the decision. SIAC's scrutiny process enhances the enforceability of awards.

Services in *Ad Hoc* Arbitrations

In addition to fully administering arbitrations, SIAC also offers a service for the appointment of arbitrators in *ad hoc* arbitrations seated in Singapore and where SIAC is designated as the appointing authority. The President of the SIAC Court of Arbitration is the statutory appointing authority under the applicable legislation in Singapore.

In 2019, SIAC was called upon to appoint arbitrators in 25 *ad hoc* arbitrations.

Concluding Remarks of the CEO
