#### Keynote Speech by Mr Chan Leng Sun, SC

Modern arbitration history in Malaysia may be traced back to 1972. Few will remember that the arbitration laws of Sabah (known as British North Borneo) and Sarawak were once more "modern" than the arbitration legislation of Peninsular Malaysia. Sabah and Sarawak had already adopted the English Arbitration Act of 1950 before they joined the Federation of Malaya. Peninsular Malaysia was still following the English Arbitration Act of 1889. This changed in 1972 when Malaysia adopted the arbitration laws of Sabah and Sarawak, and Malaysia as a whole then adopted the English Act of 1950. At that time, the Singapore Arbitration Act of 1953 was also based on the English 1950 Act. Given that Malaysia and Singapore have now come of age as popular seats of arbitration in their own right, it is opportune to review how arbitration has changed in the last 5 decades. While this public lecture reviews the progress made in Malaysia and Singapore, it will also touch on exciting developments elsewhere, particularly in Asia where the growth of arbitration has been exhilarating. This will be a journey through time as we trace the evolution of arbitration from a domestic English framework to more global sensibilities driven by instruments such as the New York Convention and the UNCITRAL Model Law, and innovations such as Expedited Procedure. Emergency Arbitration and remote hearings.
