## SIAC Welcomes New YSIAC Council and Co-Chairs

The Singapore International Arbitration Centre (SIAC) is pleased to welcome the new Young SIAC (YSIAC) Council and Co-Chairs.

YSIAC is a global platform for young arbitration practitioners to forge deep international networks, develop their arbitration practices, and build thought leadership in the arbitration community.
